Subject: Intimation of Revised Price List for products impacted by GST Rate Changes pursuant to Notifications issued after the 56th GST Council Meeting (03–04 September 2025)

Dear Sir/Madam

We, YKK India Private Limited (hereinafter referred as 'the Company'), draw your attention of an upcoming revision to our price list for the product category, e.g., slide fasteners and parts thereof including zippers, chains, sliders etc. pursuant to a recent decision by the Government to rationalize the Goods & Services Tax (GST) rate structure, effective from **22 September 2025**.

The revised rates are necessary to align with the new tax rate structure notified vide **Notification No. I-10/14/2020-W&M, dated 18 September 2025** pursuant to 56th GST Council meeting. In line with the above and in compliance with the Legal Metrology (Packaged Commodities) Rules, 2011, read with Circular No. I-10/14/2020- W&M dated 18 September 2025, we have accordingly revised the Maximum Retail Price (MRP) of the affected products so that the benefit is duly passed on to the end customer. **The revised MRPs are effective from 22 September 2025 are detailed in Annexure I below:**

In order to be fully GST compliant, both YKK India Private Limited and you as Company's business partner, would be required to pass on the benefit of reduced GST rates to the end customer. Accordingly, the following activities will be undertaken during the transition phase:

- Please ensure that the revised GST is reflected in your billing systems and clearly communicated to the customers at the point of sale.
- Any unsold inventory prior to revision of GST, bearing old MRPs may continue to be sold, provided that an updated price list reflecting the reduced MRP is prominently displayed at your retail counters, in accordance with Rule 33 of the Legal Metrology (Packaged Commodities) Rules, 2011.
- No excess amount should be charged from consumers, and the **benefit of GST rate reduction must be fully passed on.**

We view this transition not merely as a tax rate change but as an opportunity to deliver greater value to consumers. We remain committed to ensuring stability, continuity, and fairness across our shared operations and request your full cooperation in implementing this revision in a timely manner so that the benefit of tax reduction reaches the end consumers as intended by law.
